 22/0159/FH Barn, Old Mount Farm, Mount Hill, Rhodes Minnis, CT4 6YD Installation of a ground mounted solar PV array sited to the rear of the back garden.
 Resolved No objections.
 - **Re-consultation** 21/2520/FH Boyke Bungalow, Boyke Lane, Rhodes Minnis, Canterbury, CT4 6XN. The reason for the re-consultation is that revised drawings have been submitted to FHDC. **Resolved: To Object. Elham Parish Council have requested that should FHDC Planning Case Officer be minded to approve this application that it is called in for FHDC Planning Committee to decide, if the Case Officer is minded to turn down this application Elham Parish Council are happy for this to be an Officers decision.**
- 2. The received planning application since the agenda was issued was **noted** and comments **agreed**
 - 22/0673/FH/PA Land at Ottinge Pumping Station, Bereforstal Hill, Elham, CT4 6XJ Determination as to whether the prior approval of the Local Planning Authority is required under Schedule 2, Part 16, Class A of the Town and Country Planning (General Permitted Development) (England) Order 2015 for a proposed radio base station with 25m lattice tower and equipment cabinets.

Resolved: that prior approval <u>shall not be granted</u> and that a full planning application is submitted. Comments of Elham Parish Council, Elham Parish Council Telecoms Committee and Connect Elham are:

Main Points

- The proposed base station would be a significant development in the Kent Downs Area of Outstanding Natural Beauty and should be the subject of a full planning application, to ensure proper public scrutiny. Prior approval should, therefore, not be granted.
- There would be negligible benefit to Elham village. The coverage maps show that the improved 4G signal will only reach the residents of Ottinge and a few residents to the south of Elham village, on Canterbury Road. As such the harm to the Area of Outstanding Natural Beauty far outweighs the local benefits to be gained, and the application should be refused. Many references in the Supplementary Information Document to 'this area of Elham' are misleading, as the area covered is insignificant. A solution that benefits the majority of Elham parish needs to be found.

Additional Points

 No consideration is given to mast sharing when it is the Government's policy to encourage this. The impression is given that mast sharing is not

- possible for technical reasons, in which case these technical reasons need to be overcome. Otherwise, there will never be any mast sharing.
- Cornerstone appears to be trying to roll out a one-size-fits-all network of masts to suit themselves and their budgets, as opposed to considering local issues and constraints. As such, no other designs, less harmful to the Area of Outstanding Natural Beauty, have been seriously considered.
- Given that Cornerstone point out the proposed mast has to be tall in order for the top of the mast to be above the trees, it is surprising that none of the sites that they have considered are in an elevated position, where the mast, or pole, could be shorter, more integrated into the landscape and, therefore, have less adverse impact on the Area of Outstanding Natural Beauty. Cornerstone needs to look at elevated sites, even if these are more expensive and more difficult to realise.
- Cornerstone point out that a mast needs to be near to the residential area and then indicates that it has been deliberately sited away from the village, a contradiction that results in a proposed solution that is woefully inadequate.
- It is all very laudable forward planning for 5G, but when the 4G signal in Elham is so poor, that is a luxury. The signal for 4G in Elham needs to be the immediate priority.
- 3. Decisions made by Folkestone and Hythe District Council were **noted**: 22/0209/FH The Stable, Henbury Lane, Elham, Canterbury, CT4 6NL-Enlargement of existing domestic shed to form double garage. **Approved with conditions**.
- 4. The application 22/0682/FH St Marys Church The Square, Elham, CT4 6TT was noted. Resolved: No Comments to be submitted. The Clerk has contacted the Diocese of Canterbury regarding this application.
- 5. It was **agreed** that discussing a Neighbourhood Plan would be deferred to a future Ordinary meeting of the Parish Council.
