It was agreed that the Elham NHW Facebook group will be discontinued from 31/12/22 and the Elham Parish Council Facebook account used instead. This would ensure that the wider community would receive NHW information, as well as alerting people of the existence of the NHW group which they can easily join.

215/22 Planning

1. The received planning applications were **noted**, and comments **agreed**:

22/1594/FH - Recovering of existing flat roof, replacement roof lights and new rainwater downpipe and 22/1618/FH - Listed building consent for the recovering of existing flat roof, replacement roof lights and new rainwater downpipe - Verneys, High Street, Elham, Canterbury, CT4 6TD.**Resolved** – **no objections.**

22/1665/FH - Grimsacre Cottage Grimsacre Farm, Canterbury Road, North Elham, Elham, Canterbury, CT4 6NG - Proposed detached 3 bay garage and store plus annexe above. Resolved – to object. Comments of the Council were:

The Parish Council has concerns that the land is under two separate Land Registry titles, with the proposed land for the proposed building having planning constraints under agricultural land grade 3 classification, could the Planning Officer please confirm to the addressee prior to a decision being made that a change of use in the land is not required before planning applications can be considered?

The size of the proposed building seems disproportionate, and we would request that if the Planning Officer is mindful to grant planning permission that the proposed building remains ancillary to Grimsacre Cottage, Grimsacre Farm.

The proposed structure, on the west side elevation has issues of overlooking the neighbouring property.

There will be an impact on the AONB from the footpath which is also a planning constraint of the land where the proposed building is to be situated.

The proposed structure is very close to the boundary abutting the neighbouring stables. The neighbouring properties existing stables are next to the boundary line, and if this was in reverse, then the requisite would be that equestrian buildings must be a reasonable distance from neighbouring properties (permitted development).

22/1726/FH - Jacques Court, Fir Tree Hill, Bladbean, Canterbury, CT4 6NB - Listed building consent for the conversion of existing disused stable / barn to annex accommodation associated with the host house to include an extension to the South East elevation. **Resolved: to request an extension until 6th December 2022.**

22/1096/FH - Kings Arms, The Square, Elham, Canterbury, CT4 6TJ - Erection of single storey rear extensions, refurbishment of existing outbuilding to provide dining area and all associated landscaping works (resubmission of 20/0747/FH) is to be discussed at FHDC Planning Committee on 18th October 2022. -Approved with a number of conditions.

22/1110/FH - Mount Hill Cottage, Chapel Lane, Rhodes Minnis, Canterbury, CT4 6YB- Erection of rear, side and front porch extensions including walk out balcony and internal alterations. – **Approved with conditions.**

222/22 County Councillor – Susan Carey

KCC Report to Elham Parish Council 7th November 2022.

The County Council's financial situation has worsened with inflation affecting services across the board. The latest forecast is that we'll be £70m over budget by the end of this financial year so we are likely to need our emergency reserves implement extra savings in the current financial year. When we set our budget for 2023/24 we must by law set a balanced budget including the replenishment of reserves. We have always had financial challenges as demand for services, especially social care, is high but I've never known a year like it.

Despite our own financial troubles, we do still have Government grants to help individuals and families affected by the cost of living. Kent families with children who receive free school meals were once again provided with food vouchers by KCC to help them during the Autumn half-term and will be again over Christmas, the Spring half-term and next Easter. The vouchers will be available through the youngsters' school or college. A £50 energy voucher will also be available

KCC is trialling some re-use projects at a few of its Household Waste Recycling Centres (HWRCs) and, if these are a success, they'll be extended to all 19 sites. The trials are for furniture and books.

I thought you would also like to know the latest situation with the Ukrainians in Kent as part of the Homes for Ukraine scheme. Many of the original hosts are now reaching the end of the 6 month agreement but the war in Ukraine continues and the Ukrainian Government has asked that refugees do not return until after winter. Up to 12 October there have been 4,000 matched applications with 1703 sponsors in Kent which is the highest number anywhere in the UK (361 in the Folkestone & Hythe district). To encourage hosts to continue to offer accommodation over the winter, KCC is offering increased payments to March 2023. Refugees are arriving at the rate of 1 or two every day and we need more host families.
