Comments of the Council: Elham Parish Council request that further details are submitted regarding the drainage as this application does not address the issue of the current cesspit problem.

# 2. Community and Amenities

- i. *Church wall* the tender packs are to be prepared and sent to contractors for full Council approval.
- ii. **Burial Ground** -the quotation received for memorial testing was discussed and it was **agreed** to proceed with the cost of £150 per day for a total of two days. It was **agreed** that Cllr Clements would arrange a site meeting with the Grounds Maintenance Contractors to discuss pruning the trees to the rear of the burial ground.
- iii. *The Gore* We are still waiting for a decision from FHDC. The latest decision date on FHDC portal was 15<sup>th</sup> August. When asked the Case Officer advised that it could be another 3 to 4 weeks, depending on his workload, before a decision is received.
- iv. *Community Orchard* Planting days have been arranged for Saturday 14<sup>th</sup> October and Sunday 22<sup>nd</sup> October. The Clerk is to arrange delivery etc and refreshments. Flyers to be distributed.
- 3. **Staffing Committee** Further to the Clerks appraisal at the Staffing Committee meeting on 4<sup>th</sup> September 2023 it was **agreed** by full council that: The Clerk to remain on increased hours until the next Staffing Committee meeting in March 2024. The Clerk Salary would increase to spinal column point SPC21 23/24 back dated to 1<sup>st</sup> April 2023.

KCC Report for Elham Parish Council 04 September 2023

The outbreak of avian flu identified at a farm near Elham has now been successfully contained. KCC and Defra staff alerted residents to the problem so that domestic birds could be kept indoors, and everyone be aware of the risk. Although this outbreak is over, people are being asked to continue to be vigilant for dead birds and to report them to Defra. I was wrong to say avian 'flu is not harmful to humans as it seems it can occasionally cause illness with symptoms ranging from mild respiratory issues to severe pneumonia. The disease spreads through direct contact with bird droppings, infected birds or contaminated surfaces.

Asian hornets have been spotted in several parts of Kent including Hawkinge and Etchinghill. They have orange faces, yellow legs and are bigger than a wasp. They are voracious predators of other insects and Defra is trying to identify and destroy nests before the young emerge. Please report any sightings to nonnativespecies.org

There has been much attention lately in the media about school buildings which have RAAC (Reinforced Autoclaved Aerated Concrete) material in them. Six schools in Kent were identified as having RAAC and the affected areas were taken out of use before the summer. There are no further schools that KCC has been made aware of by

the Department for Education that have RAAC. Checks have been done at schools that might be at risk and academies have been offered a survey.

KCC has used some of our Bus Service Improvement Plan grant from the Government to help fill gaps caused by Stagecoach's withdrawal of services. The focus has been on services used by schoolchildren. If people use the buses their future is secure. BSIP funding is only for the next two years and there is no guarantee it will continue.

The situation with Unaccompanied Asylum-Seeking children remains unresolved and KCC has had to issue another notice to say we cannot safely accept more children into our care. The extra numbers have added to already swerve financial pressures in social care and we are taking further action to make savings.
